TOWN COUNCIL SET TO RETURN IN PERSON

The Moraga Town Council is set to return to the Town Council Chambers for the first in-person meeting in two years. The March 23, 2022 Town Council meeting will be held at the Council Chambers building located at 335 Rheem Blvd. Council meetings begin promptly at 6:30 pm. The move comes as COVID-19 cases continue to decline in Contra Costa County. Minor modifications to the layout in the Council Chambers will allow for additional distance between attendees.

The Town's Boards, Commissions, and Committees will be evaluating in the coming weeks both virtual and in-person meeting options.

The virtual option has worked well for some public meetings and is an option that may be used for community meetings. In person meetings are being considered by the Town's Commissions and Committees on an individual basis. The Town Council renewed and continued the Local Emergency in March to remain responsive and enable the return to a virtual meeting format should the need arise.

The tour of Moraga Center will start at Canyon Club Brewery at 4:00 pm. Each tour is expected to last 45 minutes. Maps and a detailed and visual overview of the proposed housing locations will be provided.



A demonstration of the Balancing Act Tool simulator will also be featured. Please bring water and good walking shoes! Residents are encouraged to stay after the tour and mingle at Canyon Club Brewery.


SUMMER ACTIVITY GUIDE COMING SOON
