

GARBAGE, RECYCLING AND GREEN WASTE CART ROUTE REVIEW

RecycleSmart, the Joint Powers Authority that manages the Town's solid waste and recycling contracts, has retained the services of SCS Engineers to complete visual inspections as mandated by SB 1383. Inspectors in orange vests with clipboards will be looking into random garbage, recycling and green waste carts for the next few months. They WILL NOT be: 1- imposing any fines; 2- taking photos; 3 – touching the materials in the carts; or 4 – dumping the contents of the cart. They WILL be placing either a "Good Job" or "Oops" tag with information on what belongs where.

TOWN COUNCIL ACTIONS ON OCTOBER 12, 2022

PENSION RATE STABILIZATION PROGRAM

Representatives from PARS (Public Agency Retirement Services) provided an overview of Section 115 Trust accounts as a mechanism for the Town to invest funds now to stabilize future unfunded pension liability payments. View the [staff report and Presentation](#). The Council requested staff bring an agreement with PARS to the October 26, 2022 meeting for consideration.

RECRUITMENT AND SELECTION OF NEW TOWN MANAGER

The Council discussed the selection process for recruitment of a new Town Manager in response to Cynthia Battenberg's retirement from city management at the end of the calendar year. With agreement to use an executive recruitment firm, the Council formed a Town Manager Recruitment Ad Hoc Committee for the next two weeks to interview firms and bring a recommendation to the Council on October 26, 2022. COMPREHENSIVE ADVANCED PLANNING INITIATIVE

The Town Council received an update on the Comprehensive Advanced Planning Initiative including review of prioritized tasks to support the adoption of the Housing Element by the State deadline. The Housing Element, Environmental Impact Report (EIR), General Plan Consistency Amendments, and Safety Element are all required components for the adoption of the Housing Element and are on a critical path proposed for completion by February 22, 2023. The State law provides an additional 120-day allowance beyond the January 31, 2023 date to May 31, 2023, commonly referred to as the "grace period." The Rezoning and Objective Standards can be phased in the March/April timeframe. View the [staff report](#) and [Power Point presentation](#).

FLAVORED TOBACCO AND ELECTRONIC SMOKING DEVICES ORDINANCE

The Council reviewed an Ordinance amending the Municipal Code to prohibit the sale of flavored tobacco and electronic smoking devices, also known as vaping devices, within the Town on January 1, 2023. The Ordinance is similar to Ordinances approved in both Orinda and Lafayette, as well as other Contra Costa County cities. Flavored tobacco is seen as a gateway to other tobacco products as the flavors cover or lessen the harshness of the tobacco and appeal to kids. Likewise, the liquids used in vaping devices are often flavored. 92% of Contra Costa high school students who use tobacco reported using a flavored tobacco product. The Council held a public hearing and introduced and waived the first reading of the Ordinance. The Ordinance will return at a future meeting for a second review and approval. AMENDMENTS TO FISCAL YEAR 2022/23 CIP BUDGET

Town Council reviewed and accepted the Fiscal Year (FY) 2022/23 carryover budget amendments. The first quarter assessment reviewed the prior fiscal year's actual ending revenues and expenditures to identify major variances between actual transactions and estimated budget amounts due to the timing of consultant and contractor invoicing and work delays. The reduced actual expenditures necessitate the carryover of unspent funds to the current fiscal year to cover planned and needed work for open and awarded contracts. View the [staff report](#).

ELECTRIC VEHICLE CHARGING STATIONS ORDINANCE

Town Council adopted an Ordinance to create expedited permitting procedures for electric vehicle charging stations (EVCS), which would bring the Town into conformance with State Law. There are four main drivers for requiring expedited processing of applications for electric vehicle charging stations: timely and cost-effective installation of EVCS, promotion of the use of EVCS, removal of obstacles and reduction in the cost of permitting and administrative approval through the permitting process. LANDSCAPING RIGHT-OF-WAY ORDINANCE

The Town Council adopted an Ordinance amending the Moraga Municipal Code to clarify abutting property owners' responsibilities within the Public Right-of-Way (which includes the sidewalk area from the roadway edge to the private property line) for maintaining trees, shrubs, hedges and other improvements and landscaping. The Ordinance goes into effect 30 days after the adoption. View the [staff report](#).

PROCLAMATION COMMITTING TO FREE AND FAIR ELECTIONS

The Town Council endorsed a proclamation "Committing to Core Principles of Democracy – Free and Fair Elections." In doing so, the Council declared the Town of Moraga recognizes and supports the fundamental right of voters to decide the outcome of our elections and stated the Town would continue to support elections that are safe, free and fair.



APPLICATIONS FOR CIVIL GRAND JURY SERVICE SOUGHT

Do you have what it takes to be a civil juror? The Contra Costa County Superior Court is accepting applications for Civil Grand Jury Service for the Fiscal Year 2022-23 term. The Civil Grand Jury is made up of 19 members who serve for one year, July through June, to monitor, review and report on city and county governments, special districts and school district programs.
