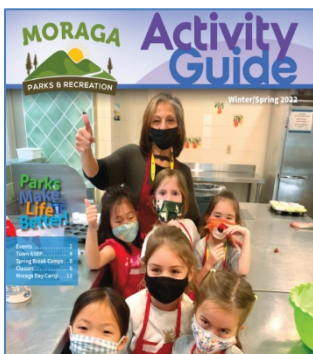


BUY A BULB FUNDRAISER

RECENT TOWN COUNCIL ACTIONS ON DECEMBER 8, 2021

THANK YOU MAYOR MCCLUER

Outgoing Mayor Mike McCluer gave a [presentation](#) on the Town's accomplishments this past year which included improved fiscal sustainability, launch of the Advanced Planning Initiative, progress on construction of the Canyon Road Bridge, investment in the Town's streets and public storm drain system, a partnership with Wedgewood Weddings for events at the Hacienda, and a focus on traffic safety, diversity and inclusion. Mike was recognized for his energy and commitment to stakeholder engagement.

NEW MAYOR AND VICE MAYOR ELECTED FOR 2022

The Town Council conducted their annual reorganization. Renata Sos was elected Mayor for 2022 and Sona Makker was elected Vice Mayor. Congratulations Renata and Sona!

OPIOID SETTLEMENT AGREEMENT

The Town Council agreed to participate in a settlement agreement involving a lawsuit filed against opioid manufacturers, distributors and dispensers by a number of jurisdictions across the country. The Town will receive between \$59,000 and \$70,000 over the next 18 years for use in battling opioid addiction and overdoses. The Town can also decide at any time to redirect the funds to the County for use in their programs.

SMALL CELL WIRELESS ORDINANCE

Town Council waived the second reading and adopted an Ordinance to amend sections of Moraga Municipal Code 8.144.010 for Small Cell Wireless. The amendments include, but are not limited to, location and configuration preferences, design and installation, signage, landscaping, noise and other standards. Council added a condition that requires Small Cell Permittees to comply with the most current applicable Radio Frequency emissions standards and additional testing at the time of renewal. FISCAL YEAR 2021/22 SALARY SCHEDULE AMENDMENT

The Town Council adopted a resolution amending the current Fiscal Year 2021/22 Salary Schedule for the Recreation Leader I (PT), Facilities Attendant (PT) and Intern Classifications to comply with the State of California minimum wage increase effective January 1, 2022, and for the Recreation Leader II (PT) classification to address compression and for the Maintenance Worker (PT) classification to establish a competitive rate for the position.

TOWN AWARDED \$470,736 DEPARTMENT OF JUSTICE TOBACCO GRANT

The Town Council voted to accept a \$470,736 grant from the Department of Justice Tobacco Grant program, enabling the Moraga Police Department (MPD) to hire an additional officer and focus upon tobacco-related education and enforcement in the community. Tobacco and vaping are issues in Moraga as a recent California Healthy Kids Survey revealed that 36% of Campolindo 11th graders had used a vaping device and only 37% of 9th graders believed that occasional cigarette smoking was harmful. Additionally, the 2019 Merrill Fire is believed to have been caused by a discarded vaping device.

CANYON ROAD BRIDGE CONTRACT AMENDMENT

The Town Council amended the NV5 consultant contract to continue providing construction support services on the Canyon Road Bridge project. Construction is nearing completion and should be completed by early 2022. For more information, please visit the project's [webpage](#).

TOWN ACCEPTS \$80,000 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)

Town Council accepted CDBG grant funds from Contra Costa County for the construction of ADA improvements at the Hacienda, including the pathway from the parking lot to the building and the fountain patio area. Construction is scheduled to be completed in February 2022.

TOWN PURCHASES ITS FIRST PLUG-IN HYBRID VEHICLE

The Council approved the purchase of a 2022 Ford Escape SE Plug-In Hybrid vehicle with improved fuel efficiency (105 MPGe), traveling approximately 37 miles fully charged. The vehicle is replacing a 2002 Chevrolet Impala getting 15 MPG with 120,000 miles and substantial deferred maintenance costs. This vehicle will afford the Town the opportunity to utilize lower cost electric charging for many of the local Town activities and substantially reduce greenhouse emissions.



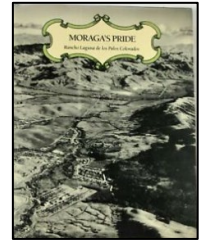

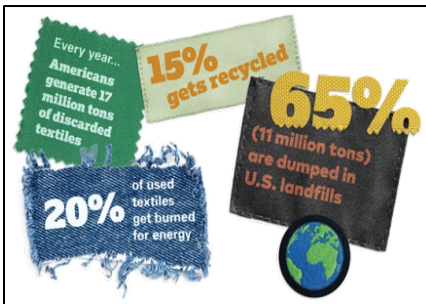


HOLIDAY GIFT IDEAS FROM THE MORAGA HISTORICAL SOCIETY

The California Environmental Quality Act (CEQA) [Initial Study/Mitigated Negative Declaration](#) (IS/MND) for the St. Mary's Road Roundabouts Project has been completed. The IS/MND will be presented to Council for adoption at the March 23, 2022, Town Council meeting.



MCE 2021 IMPACT REPORT

The MCE 2021 Impact Report highlights MCE's successes over the last year. Key highlights for 2021 include: MCE's "A" credit rating from S&P Global; California Community Choice Financing Authority launch; a cumulative reinvestment of \$180 million in MCE communities; receiving 99% of power supply from clean resources; offering new resources to support our customers during the COVID-19 pandemic; issuing a resolution to Advance Racial Equity; and the Green Access and Community Solar Connection programs.
