### ROAD BRIDGE CLOSURE - FRIDAY, JUNE 10

The Canyon Road Bridge will be closed to all traffic (except for emergency vehicles) tomorrow, June 10 from 9 am to 4pm. The closure is necessary to repave of sections of the bridge roadway approach. Bridgeway Constructors, the bridge contractor, started completing the final punch list and should be finished by the end of June. Typical work hours are Monday to Friday 8 am - 5 pm and temporary traffic signals are in place with one lane operation over the bridge for the duration of construction. Please expect delays of 15 minutes or more during work hours. There may be additional roadway closures in the coming weeks. Closure information will be provided on the [Bridge Project website](#) and posted on the changeable message signs near the bridge.



### ROAD CLOSURE ALERT - WEDNESDAY, JUNE 15

There will be several residential Road Closures for road construction on Wednesday, June 15. This first phase of pavement resurfacing will take place on Amberwood Court, Archer Circle, Ashford Place, Cypress Point Way, Fernwood Drive, Fleuti Drive, and Selborne Way. The rubber chip seal operation will affect street access for several hours, except for emergency vehicles. ### RECENT TOWN COUNCIL ACTIONS ON JUNE 8, 2022

#### ***FY 2022/23 OPERATING AND CAPITAL IMPROVEMENT PROGRAM BUDGETS***

The Town Council received a presentation on the \$24.9 million [FY 2022/23 Proposed Operating and Capital Improvement Budget](#) which includes funding for essential services and a \$13.6 million Capital Improvement Program. The Proposed Budget reflects the Council's goals and input received during preliminary budget discussion items brought before the Council the past few months. The Council directed staff to add a \$250,000 contribution from Fund 100 – One Time Developer Fees (Palos Colorados) to the John Muir Land Trust (JMLT) for the acquisition of Harvey Ranch for open space. #### ***LOCAL ROADWAY SAFETY PLAN***

TKJM, the Town's traffic safety consultant, provided a [Local Roadway Safety Plan \(LRSP\) presentation](#) and results of their analysis in their draft LRSP report and requested feedback from the Council and community. This was the second of three anticipated meetings in which the LRSP will be presented. The final LSRP presentation and report is tentatively scheduled for July 13, 2022 Town Council meeting.
