MOBILE MORAGA AVAILABLE NOW!



The Town has launched Mobile Moraga which enables citizens to report nonemergency concerns to the Town. The FREE app is now available for download in the App Store and in Google Play. Citizens can also report concerns through Mobile Moraga on the Town's website under "Quick Links". Mobile Moraga also provides a comprehensive listing of Town services right at your fingertips. The functionality of the new work order system allows the Town to streamline the work order process improving efficiency.

SCHOOL BUS SAFETY

The Moraga Police Department (MPD) has been receiving a number of traffic complaints about speeding in school zones and drivers passing school buses that are displaying flashing red lights. These lights signify that children are getting on or off the bus and there is a danger of a child darting out into traffic. Drivers in both directions are required to stop while the red lights are flashing. If the road has a median or more than one lane in each direction, drivers must stop for a school bus in their direction. Additionally, the vehicle speed limit in school zones is 25 MPH when children are present. Officers, even the Chief, are enforcing these laws and issuing citations to keep our roads safe for drivers and children. Please assist the MPD by driving cautiously and obeying the traffic laws. RECENT TOWN COUNCIL ACTIONS ON MAY 8, 2019

MASTER FEE SCHEDULE APPROVED

As part of the annual budget process, the Town Council adopted a resolution to authorize updates to the Town's Master Fee Schedule. The FY 2019/20 updated Master Fee Schedule lists all the fees and charges by department to offset the Town's costs in processing permits, licenses, subdivision maps and entitlements and other services. The updated Master Fee Schedule will become effective July 7, 2019 and is integrated in the proposed FY 2019/20 budget.

STREET LIGHTING ASSESSMENT DISTRICT

In order to maintain and continue the street lighting assessment district, the Town is required to conduct an annual levy and collection process. Town Council approved the Engineer's Report, declared the intent to levy and collect assessments for Fiscal Year 2019/20, and set a Public Hearing date of June 12, 2019.

\$2.65 MILLION FHWA EMERGENCY RELIEF REIMBURSEMENT

The Town's is scheduled to receive \$2.65 million from the Federal Highway Administration Emergency Relief in reimbursement for the temporary Canyon Road bridge project prior to fiscal year end, June 30, 2019. \$1 million will be used to repay a loan from the One-Time Developer Fees Fund (Palos Colorados). The remaining \$1.65 million will repay a General Fund loan. \$745,000 is needed to restore the General Fund reserve to the Town Council's goal of 50%. The Council discussed how to best allocate the \$825,000 in one-time funding to priority projects and directed staff to: fund a 2019 Storm Drain Master Plan Update and the Bollinger Valley Study Area General Plan amendment and rezone; contribute to the Storm Drain Operations and Maintenance program; and allocate \$255,000 to the Asset Replacement Fund to start to address the backlog of projects.

CLIMATE ACTION PLAN IMPLEMENTATION UPDATE

The Town Council was given an <u>update</u> on the progress in implementing the goals and strategies of the Town's <u>Climate Action Plan</u>. After considering recommendations from staff, the Council voted unanimously to direct staff to pursue three projects: (1) installing public electric vehicle charging stations at the Town offices and the main Moraga Commons parking lot; (2) installing public water bottle refilling stations with built-in water fountains at the Town offices and the Council Chambers; and (3) undertaking various energy-efficiency lighting and HVAC system upgrades at all four Town properties. The EV charging stations and water bottle refilling stations will be funded by General Government Facilities Impact Fees which are restricted to capital improvements to government buildings. The energy efficiency upgrades will be funded using 0% interest financing with an estimated payback period of 5.4 years.

FIRE PREVENTION PRESENTATION

Chief Winnacker provided information on the Moraga-Orinda Fire District's (MOFD) efforts to mitigate wildland fire risk which included information on high severity zones; history on major past fires and the role of Diablo winds; the importance of fire breaks and their multi-agency work to coordinate more effective breaks; the importance of defensible space; and community evacuation planning. MOFD has been proactive in fire prevention efforts which include notifying residents that vegetation needs to be removed, following up with education and if needed, mitigating and charging for the service. MOFD shared that they will provide free inspections and advice (call 925-357-1909) on how to maintain defensible space around your house. MOFD also has a free chipper which they will deliver to your home when five or more property owners coordinate their efforts. Watch the informative presentation on Livestream. MOFD is scheduling a Wildfire Forum on Wednesday June 5, 7:00 pm at the Joaquin Moraga Intermediate School auditorium, including information on evacuations, preparedness and community alert systems.

The Town Council honored the Moraga Police Department by declaring May 11 to 17 as Police Week and May 15 as Peace Officers' Memorial Day. These declarations are authorized by Federal Law and honor the ultimate sacrifices made by peace officers throughout the country. The Moraga Police Department also honors Moraga Police Officer Mary Anne Borden, who died in 1988 from cancer. Thank you to all MPD officers for their service to the Moraga community.
