Dear Beatriz Portillo:

The Federal Emergency Management Agency (FEMA) received documentation on July 16, 2025, confirming that the Cities of Brentwood and El Cerrito, Reclamation District 2065, San Ramon Valley Fire Protection District, and Town of Moraga have officially adopted the 2024 Contra Costa County Hazard Mitigation Plan. FEMA confirms the jurisdictions are in conformance with the Code of Federal Regulations, Title 44, Part 201, Section 6 (44 CFR 201.6). An updated list of the status of participating jurisdictions is enclosed.

The 2024 Contra Costa County Hazard Mitigation Plan has an approval date of September 18, 2024, for all participating jurisdictions. To maintain grant eligibility, all participating jurisdictions must review, update, and resubmit the plan to FEMA before **September 18, 2029**.

While local mitigation plans may include additional content to meet Element H: Additional State Requirements or other local objectives, FEMA's approval only applies to elements required by its *Local Mitigation Planning Policy Guide* (FP-206-21-0002).

This plan approval ensures eligibility for project grants under FEMA's Hazard Mitigation Assistance programs, including the Hazard Mitigation Grant Program (HMGP), HMGP Post-Fire, Flood Mitigation Assistance (FMA), and Safeguarding Tomorrow Revolving Loan Fund (STORM RLF). Funding requests are reviewed individually for eligibility and other program requirements.


